



# TAXPAYERS SUCCESSFULLY GET BACK ON TRACK

WITH THE IRS PRIVATE DEBT COLLECTION PROGRAM

Each year, a subset of taxpayers appropriately file federal tax returns, but do not pay the taxes due – resulting in approximately \$50 billion in uncontested, uncollected, federal tax revenue. Taxpayers get behind on their taxes for a variety of reasons – feeling overwhelmed by the paperwork, too busy to follow-up with the IRS, sidetracked by a disruption in their life or facing a temporary financial hardship.

As a result, the IRS Private Debt Collection (PDC) Program was created by Congress to offer a collaborative, flexible and supportive solution for taxpayers with uncontested tax underpayments. The PDC Program permits taxpayers to design installment payment plans – tailored to fit their personal budgets – to help pay down a tax debt over time. Participation in the PDC Program is voluntary, and those participating also have the ability to restructure their chosen payment plans along the way if their circumstances change.

## THE FIRST 5-YEARS OF THE PDC PROGRAM HAVE WORKED SEAMLESSLY FOR BOTH TAXPAYERS AND THE FEDERAL GOVERNMENT.
